

EPA Environmental Guidelines: Pollution Incident Response Management Plan

Potential Pollutants 98C(1)(a)&b - November 2015

Dust
Noise
Diesel Fuel
Lubrication Oil
Water

Pre-emptive action: clause 98C (1)(c)

Dust

Material stockpiles are naturally moist – watered in windy conditions.
Roads watered with efficient Water Truck.
All loads leave site covered.
All trucks leave site via wheel wash to remove material from tyres.
Wheel wash cleaned of sand regularly.
Hi Vol PM10 Monitoring as per Project Approval
Weather Station Triggers as per Project Approval

Noise

Adhere to conditions of consent for operating hours & restraint shown when wind direction & strength increase impact.
Weather Station Triggers as per Project Approval

Diesel Fuel

Storage of fuel is in a bunded site tank.
Fuel delivery hose has flow cut out nozzle.
Equipment fuel filling is observed.
Spill Kit is available on site if required.

Lubrication Oil

Both new & old oil stored on bunded pallets.
Used oil removed from site by licensed operator.

Water

Site cut-off drain maintained to divert clean water.
Water storage dam kept below overflow pipe by monitoring replacement water.
Potential discharge area maintained with grass cover in case of extreme weather event.
Site pollution events would not need outside assistance.

Inventory of Pollutants 98C (1)(d)&(e)

Site diesel storage 12,000 Litre
New lubrication oil 600 Litre
Used oil 600 Litre

Diesel storage near site shed & weighbridge
Oil stored in workshop.

Staff Training 98C (2)(e)

Regular toolbox meetings are held with the Safe Handling of fuel and oil has been an agenda item.
Spill Mitigation equipment and discussed safe clean up at October Tool box meeting.

Reporting Pollution (from EPA website)

In most cases, concerns about pollution should be referred to the source or person causing the problem.

Duty to report incidents that cause or threaten material harm to the environment

Pollution incidents that cause or threaten material harm to the environment must be notified to each of the following authorities:

- the appropriate regulatory authority (ARA)
- the Environment Protection Authority (EPA) if they are not the ARA
- the Ministry of Health
- the WorkCover Authority
- the local authority, e.g. the local council, if this is not the ARA
- Fire and Rescue NSW.

The [notification protocol](#) provides guidance and contact numbers to assist in notifying these pollution incidents.
